This reasonable cause statement is being submitted regarding the late filing of the 990ez for Kheyti Inc. for year ended 12.31.2016. Kheyti was incorporated on September 28th, 2016. The organization is in the process of getting their 501(c)(3) certification. Kheyti provides technology solutions for smallholder farmers currently, in India specifically.
